Since 2004 has been working at the Department of Dental Anthropology, where she participates in the teaching of integrated undergraduate and graduate studies in Croatian and English programs, and in postgraduate doctoral and specialist studies. She was elected to the title of Associate professor in 2021. The main areas of her scientific and professional work are the biology and pathology of bone tissue (especially osteoporosis and its impact on the jaw bones), dental anthropology, dental stem cells, forensic dentistry and endodontics.

<u>Title</u> - The challenge to do post graduate forensic odontology research

<u>Biography:</u> Helen studied dentistry in South Africa, settled in London as a dentist but studied further at UCL London before joining the children's section of the Dental Institute at the London Hospital Medical College. This became part of Queen Mary University of London. Her research has described the timing of deciduous and permanent teeth using known-age-at death skeletal remains and dental radiographs. Her research has tested the accuracy of dental age estimation methods using developing teeth and has improved the way this is done.
